MISTRA FINANCIAL SYSTEMS: AN OVERVIEW

Mistra Financial Systems (MFS) commenced in 2016 with the purpose of investigating how financial systems could be better utilized towards the goal of sustainable development of the society. More specifically, the program supported research that aimed to identify the root causes of unsustainable practices, assess the sustainability impact of current financial practices and addressed the technical challenges to identifying, providing measuring sustainable outcomes. distinguishing feature of MFS has been its approach answering to questions, which manifested itself through the support of interdisciplinary research projects across finance, business administration, economics, natural sciences and philosophy. This interdisciplinary approach is particularly reflected in the distribution of the program's five work streams at different academic institutions with respective focuses on economics and finance, technology, and socioecological systems: The five research teams have been anchored at the Stockholm School of Economics (SSE), the Lochlann Quinn School of Business at the University College Dublin (UCD), the KTH Royal Institute of Technology, the Stockholm Resilience Center (SRC) and the Stockholm Environment Institute (SEI).

Besides an eclectic mix of researchers, the program has benefitted immensely from the experience of its governing board which comprised of experts from finance, economics, politics and international academia. While Peter Norman, former Swedish Minister for

Financial Markets chaired the Board, other members included Ingrid Werner, Professor in Finance at the Ohio State University, and Per Krusell, Professor in Economics at the Stockholm University's Institute for International Economic Studies and member of the committee of the Swedish Riksbank Prize in Economic Sciences in Memory of Alfred Nobel. In 2019, Michael Halling, Associate Professor at SSE and Research Fellow at the Swedish House of Finance took over the executive leadership of the program from his colleague Professor Bo Becker, a transition that brought MFS closer to the Mistra Center for Sustainable Markets where Professor Halling is affiliated with the Sustainable Finance research initiative.program

Over the course of five years, MFS has served as a platform that has produced a range of new research papers, articles in prominent journals as well as a variety of outreach activities and educational events before concluding in 2020. The research and discourse supported by the platform has been insightful for both public and private decision-making while also laying the foundation for regulatory reforms of the financial sector. Besides being beneficial to key financial actors including banks, institutional investors, venture capitalists and insurance companies, the MFS program has contributed to enriching the literature for a global community of researchers and students. This final report recapitulates important research findings and discusses their impact through key outreach and educational activities undertaken over the course of five years.

1.1 RESEARCH FRAMEWORK

MFS investigates ways to put financial systems to work for sustainable development of the society, using five broad perspectives: Embodied in the work streams 'Green Macro', 'Policy', 'Market Drivers', 'Governance' and 'Practical Tools', different levels of agency and actors on the micro-, meso- and macro-level and varied time scales (from shorter to longer term) are approached to answer particular research questions. The former three work streams take a system perspective including the natural environment, the political economy and the special characteristics of "sustainable markets", for instance the market for renewable energy or the specific needs of sustainability start-ups, while the latter two use established finance theories and methods to adjust asset valuation techniques with regard to sustainability issues, enhance corporate reporting and decrease information asymmetries between issuers and investors, as well as households, and assess different incentives and regulatory frameworks to correct market failures in the financial sector. A brief overview of each workstream is provided below.

GREENMACRO

The aim of Green Macro is to study the dynamic behavior of macro-financial systems on the path to a decarbonized society. The stream combines macroeconomic modelling, empirical techniques and political economy analysis to study:

i) the potential risks of financial instability linked to the low- carbon transition, ii) how financial regulators could mitigate these risks, iii) the implications of a long-term 'secular stagnation' for sustainable investments

MARKET DRIVERS

The central theme is modeling directed technical change to study implications of environmental policies for a renewable energy transition. The research focuses on:

i) the importance of the financial sector for innovation in clean tech ii) analyzing Swedish innovation data, iii) facilitating technical change through access to finance and regulation

P O L ICY

The ambition behind the policy projects is to explore policies for financial transition. In contrast to "Governance", the emphasis is more on holistic and long-term questions that address how financial systems can be transformed to properly account for ecological and social matters, not only profit. Important topics are:

i) policies and partnerships for transition, ii) public investments as leverage for transition, iii) linkages between finance and ecosystems

GOVERNANCE

Which structures of financing, governance and practices within the financial industry are beneficial or counteractive for sustainable development? More specifically:

i) the demand side, investment behaviour and financial product design, ii) diversity and governance iii) finance for sustainable firms and angel investors

PRACTICAL TOOLS


How can the different financial institutions in the current system work for sustainable development? The stream uses empirical research to develop tools for investors to assess and measure sustainability via:

i) evaluating the effectiveness of investments, ii) evaluating carbon disclosure, iii) developing benchmarks and indicators for the importance of different sustainability goals

1.2 OBJECTIVES AND DELIVERABLES

The MFS research program has been carefully designed in all parts - including the choice of participants, research projects and events based on a number of visionary ambitions. The program ultimately aimed at creating lasting impact by bringing about real changes in financial systems to enable them to work for sustainable development of the society. A second ambition was to achieve academic excellence to produce cutting-edge research that is competitive on the international level and will inspire further research in a variety of academic fields. Α third aim transdisciplinarity in research that tackled problems both practical and theoretical in nature, short and long term and at the micro and macro levels beyond the confines of traditional academic disciplines. User relevance was the fourth objective designated to bring together experts from industry, society and academics to produce relevant and practicable results. The fifth goal was to deliver early results that address urgent sustainability needs and can be put to practice directly. The final purpose was to be *flexible*, to be open to future developments in both society and academia and to be able to adjust research activities in the light of such developments.

The principle disciplines that are brought together under the platform include microeconomics, macroeconomics, financial economics, management studies, sustainability science and philosophy. This interdisciplinary approach aims to identify problems and solutions that are otherwise lost in the confines of traditional disciplines and facilitate easier comparison between solutions for sustainable finance that are put forward by diverse disciplines. The research program was designed to benefit three key stakeholders in the society, viz. the financial sector, policy makers and government agencies and the general public. The tools and metrics designed under the Practical Tools work stream, the flexible modelling framework freely made available by the Green Macro work stream and the research on governance and financing schemes for sustainable finance are targeted for the financial sector. The research on the interplay between public policies and the practices of financial institutions evaluation of some of the concrete policy suggestions for sustainable finance will continue to serve as an important guide for policymakers. Finally, a number of subprojects under the Market Drivers work stream explicitly factor in the role of end consumers which form the uncollective yet key stakeholder.



2 MFS IN NUMBERS: IMPACT AT A GLANCE

A set of four metrics have tracked the progress of the MFS platform in meeting its ambitious objectives. Together these metrics aim to assess the impact of the MFS program covering the scale and scope of high-quality research, stakeholder engagement, public discourse and educational activities. The KPI for research and academic excellence is captured by the **number of peer-review publications, working papers and book chapters published**. The engagement of the scientific community and academic dissemination of research is denoted by **conference participation**. The third metric is the **number of outreach activities** undertaken that increased stakeholder engagement and awareness such as media articles, interviews, seminars, roundtables and academic presentations. Finally, a fourth metric, i.e. **educational and scientific activities** records noteworthy high-impact events such as workshops, scientific reports, research seminars, database compilation, executive education and university courses conducted with the support of the MFS program.

Out of the 55 journal articles published or under review across five years, 12 have been published in journals that feature in Financial Times' top 50 journals in compiling FT Research Rank such as *Journal of Financial Economics, Journal of Business Ethics, Journal of Finance, Management Science, Research Policy* and *Review of Financial Studies*. More than 35 publications have been in journals with an impact factor of 3 or higher. Further, 9 publications have been in journals with an AJG ranking of four or higher. Table 6 presents the number of citations accrued by research papers on Google Scholar under respective streams as of January 2021 reported against their year of publication. Research papers supported under the MFS platform have been cumulatively cited more than 1200 times. As many as 24 papers published have been cited more than 10 times on Google Scholar although recently published papers, for obvious reasons, tend to have a lower citation count. Affiliated researchers presented their research in over 80 conferences all over the globe including the PRI Academic conference, NBER Behaviour Finance Meeting, American Finance Association, European Finance Association, Oxford University, Hong Kong Polytechnic University, London School of Economics, Yale University and the Academy of Management.

A four-fold engagement with academia, policymakers, financial industry and the general public constituted over 300 outreach activities undertaken by affiliated researchers. Interviews and newspaper articles were published with the BBC, *Dagens Industri, Svenska Dagbladet, The Irish Times,*

The New York Times and The Wall Street Journal. Engagement with the financial industry was in the form of seminars and keynote addresses with Bloomberg, BlackRock, Danske Bank, Deloitte, Deutsche Bank, Fidelity International, SEB and S&P Global. A continued dialogue with government agencies and policymakers was characterized by engagement with EU's Technical Expert Group on Sustainable Finance, Swedish government agencies, Central Bank of Ireland, Central Bank of Hungary, Austrian Central Bank, European Investment Bank and the European Commission.

For example, the final outreach event of MFS took place on April 27, 2021, in an online format due to the Covid-19 pandemic. It featured three presentations of influential research by Prof. Anders Anderson (SSE), Prof. Gustav Martinsson (KTH) and Prof. Andreas Hoepner (University College Dublin) that was conducted within the MFS framework. Those presentations were complemented by comments and a final panel discussion including Viveka Hirdman-Ryrberg (Head of Corporate Communication & Sustainability, Investor AB), Peter Norman (former Swedish Minister of Finance) and Emma Sjöström (co-director of the Finance Initiative of the Mistra Center for Sustainable Markets at SSE). Around 50 participants attended the event and contributed to a lively and engaging discussion.

The groundwork for supporting future research was laid with the creation of firm-level and international datasets in a way that ensures compatibility with the commercial Seranno/ Bisnode database. Further, a number of university courses and executive education initiatives were designed to ensure that engagement with sustainability issues continues beyond the conclusion of the MFS program. The research and outreach activities of each work stream are discussed in greater detail in the subsequent chapter.

3 MFS IN REVIEW: RESEARCH AND DISSEMINATION

3.1 Green Macro

Research Highlights:

In 2016, the long-term ambition of the project was defined as developing a comprehensive analysis of the links between natural and financial systems and supporting the development of a fair, sustainable and prosperous society. Seminal work during the year included a presentation by Eric Kemp Benedict titled "Secular stagnation, the degrowth agenda and the demand side of growth" at the International Conference of Post-Keynesian Economics as well as multiple conference presentations of the research paper on stranded assets and financial risk by affiliated researcher Emanuele Campiglio. Additionally, the research stream laid the foundation for producing a prototype of a macroeconomic model that would be numerically calibrated to the Swedish economy.

Multiple research projects and publications were supported under the research stream in 2017. Emanuele Campiglio co-authored a paper that examined how climate-related behavioral biases in the financial system affect low-carbon transition by modelling the transition to a low-carbon capital stock with modified investor expectations. The paper was also presented at multiple conferences around Europe. Further, the project supported a policy paper by Matikainen et al., (2017) which studies the climate impact of quantitative easing and is aimed at enhancing the knowhow for public, private and third-party decision-makers. Another research paper co-authored by Emanuele Campiglio focused on investigating the relevance of a 'a cascade of asset stranding' by developing a novel measure of 'basic centrality' to identify relevant economic sectors. In line with the project's objective, role for central banks and financial regulators in combating climate change was also presented by Emanuele Campiglio at the EARE Annual Conference in Athens.

The subsequent year saw two important research publications in highly ranked journals. The research paper by Emmanuel Campiglio was published in Nature Climate Change and addressed climate change challenges for central bank and financial regulators by discussing potential research and policy avenues for the future. This paper was also presented at the Society for the Advancement of Socio-Economics in Kyoto. Another research paper by Eric Kemp-Benedict presented a model representing investment-macroeconomic interactions which throws light on the poorly understood role of private

investments in major economic transition. Further, 2018 saw two conference paper presentations by Antoine Godin which focused on published research papers in 2017.

In 2019, three papers: "Cascades of stranded physical assets", "Looking for the inverted pyramid: An application using input-output networks" and "Pushing and pulling our way to a greener future" were presented at the European Society of Ecological Economics (ESEE) conference in Finland. Notably, the paper "Cascades of stranded physical assets" was awarded the Best Regular Paper prize. The research paper was also presented at the Global Research Alliance for Sustainable Finance (GRASFI) conference and won the Best Paper Prize for Research in Climate Finance.

Emanuele Campiglio co-authored an article titled "Looking for the Inverted Pyramid: An Application Using Input-Output Networks.", which was published in *Ecological Economics* in March 2020. Further, a book chapter co-authored by Emanuele Campiglio, Antoine Godin and Eric Kemp-Benedict was accepted for publication in the Routledge book *Complexity and climate change: a political economy approach*. Two journal articles authored by researchers Eric Kemp-Benedict and Antoine Godin were submitted for publication to *Metroeconomica*.

Outreach and other events:

A number of outreach and educational activities were supported by the Green Macro research stream during the five years of the project. These included presentation of the published papers by Emanuele Campiglio, Antoine Godin and Eric Kemp-Benedict at various platforms including the European Money and Finance Forum, European Investment Bank, Central Bank of Hungary, Investment Innovation Benchmark (IIB) and the European Association of Environmental and Resource Economists. Further, academic workshops were supported at the Institute for New Economic Thinking Young Scholars Initiative (Inet YSI) and for the Summer School in Paris. Notably, Emanuele Campiglio was invited as a visiting scholar at the International Institute of Green Finance in Beijing during September 2018. Eric Kemp-Benedict authored a perspective article for the Stockholm Environment Institute (SEI) titled "The Realism of the Green New Deal" in 2019.

3.2 Policy:

Research Highlights:

In 2016, the policy research stream took a step towards its defined objectives by supporting a number of book chapters and a published journal paper. Joakim Sandberg, an affiliated researcher, authored a book chapter in *Institutions for Future Generations*, published by the Oxford University Press which addresses goals, expertise and reporting that more directly factor in future generations and fragile stakeholders. Another book chapter published in *Understanding Ethics and Responsibilities in a Globalized World* focused on the issue of shareholder primacy acting as an impediment to CSR and was co-authored by David Rönnegard and N.Craig Smith. Notably, the first publication under the research stream published under the Solutions Journal and co-authored by Victor Galaz, built on exiting debates centering the notion of *planetary boundaries* and discussed five solutions in the form of relatively unexplored elements of governance mechanisms.

The policy stream produced several new research publications and book chapters in 2017. Victor Galaz co-authored three journal articles with various acclaimed researchers pertaining to topics such as governance dimensions of globally networked risks, hyper functionality in financial markets and the potential for fully automated systems to sustain new wilderness. Articles were published in established journals such as *Trends in Ecology and Evolution, Ecology and Society, Land Use Policy, Complexity, Governance & Networks, Risk, Hazards* and *Crisis in Public Policy.* Two book chapters were also published including one by Joakim Sandberg which addressed socially responsible investments and fiduciary duty as a part of the book *Sustainability and Business Law.* Further, affiliated researchers such as Thomas Hahn, Ami Golland and Victor Galaz participated in the 'Resilience Conference 2017 – Resilience Frontiers for Global Sustainability' leading the discourse on financial sector innovations required to sustain biodiversity conservation and ecosystem services.

2018 was also a prolific year in terms of research publications and conference participation. Victor Galaz co-authored a journal article titled 'Social-Ecological Systems Insights for Navigating the Dynamics of the Anthropocene' in the *Annual Review of Environment and Resources*. Thomas Hahn along with other researchers, addressed biodiversity offset policies in their article in the *Journal of Environment Planning and Management* whereas Nykvist and Maltais (2018) explored incentive structures for sustainable financing. Further, two studies under the lead of Victor Galaz, "Tax havens and global environmental degradation" and "Sleeping financial giants – Opportunities in financial

leadership for climate stability", attracted much attention all over Europe and were cited by BBC and "The Guardian". Conference participation was led by Thomas Hahn who presented at the Norwegian Academy of Science on Sustainable Transformations as well as at the FAERE Workshop in Bordeaux.

Multiple journal articles were published in 2019. For instance, Björn Nykvist co-authored a research paper titled 'Assessing the progress toward lower priced long-range battery electric vehicles' which was published in *Energy Policy*. Thomas Hahn together with Monika Suškevičs and Romina Rodela presented a synthesis of empirical literature in Natural Resource Management through their journal article in *Society and Natural Resources*. Further a number of other journal articles were published in *Nature Sustainability, Ambio, Earth System Governance, Nature Ecology and Evolution, Nature* and *The Lancet*. In 2020, Thomas Hahn co-authored two articles published in *Forest Policy and Economics* and *Transactional Environment Law*. Additionally, Joakim Sandberg published an article title "CEO Pay and the Argument from Peer Comparison" together with Alexander Andersson in the *Journal of Business Ethics*.

Outreach and other events:

The first year of the Policy project was marked by five outreach events. These included two articles in Swedish newspapers by Victor Galaz on algorithmic trade and global financial flows in tax havens. The policy stream also participated in the MFS seminars at the Royal Swedish Academy of Sciences with presentations by affiliated researcher Beatrice Crona and guest researchers Birgit Müller and David Kreuer. In 2017, outreach events were led by Björn Nykvist who conducted workshops and stakeholder interviews to identify incentives and policies essential to fostering the transition to sustainable finance. Additionally, Thomas Hahn and Joakim Sandberg presented at various seminars and conferences including a presentation for the Swedish Royal Majesty King on the rights to nature and the value of ecosystems.

The Policy project published several articles in 2018 and were particularly active in the media, with debate articles and reports in *Dagens Nyheter, Dagens Industri* and *Svenska Dagbladet*, among others. Other notable outreach activities were presentations by Thomas Hahn at "The Biodiversity Day" organized by the Swedish Biodiveristy Center and KSLA and Joakim Sandberg during the Nordea Funds Nordic Seminar.

In 2019, Victor Galaz engaged in a number of keynote addresses and lectures at Future Earth Tokyo, United Nations University, Danske Bank, Nordic Sustainable Investment Forum and Swedish International Development Agency. Further Thomas Hahn, Victor Galaz and Björn Nykvist published newspaper articles in *Svenska Dagbladet, Dagens Industri* and Biodiverse

In the penultimate year of the project, the Policy stream supported two workshops, one for the Swedish Environmental Protection Agency on sustainable growth and a second Atlas Copco Workshop which focused on sustainable transformation. Additionally, a MSc course on transformative strategies for governance and a BSc course on Ecological Economics was offered at the Stockholm University.

3.3 Market Drivers:

Research Highlights:

In the first year of the project, the research stream saw its first research publication in the form of a report based on a collaboration between MFS and the UNEP Inquiry into the Design of a Sustainable Financial System. The report explores the impact of financing difficulties on private sector innovation investments in environmental technology in the Swedish setting and is co-authored by Hans Lööf, Gustav Martinsson and Ali Mohammadi. In 2017, Hans Lööf spearheaded conference participation for the research stream with workshops and conferences in Germany, Uruguay, Sweden and South Korea. The workshop in Seoul revolved around the topic of Innovation and growth and was a part of the CESIS-KTH Soganong University Workshop Finance. Three other conference presentations in Mannheim, Montevideo and Stockholm addressed patenting of innovations in the solar industry.

The subsequent year was prolific in terms of research publications supported under the MFS platform. Several working papers and journal publications in *World Economy, Research Policy* and *Management Science* addressed the objectives and the long-term view of the project. For instance, the impact on innovation as a supply-side factor was evaluated through a research article co-authored by James Brown and Gustav Martinsson which examined whether transparency facilitated or stifled innovation. Further, the research paper co-authored by Christopher Baum explored the link between outside board members and innovative performance among start-ups whereas the journal article by Hans Lööf and Ingrid Ros-Viklund examined the implication of outside and interlocking directors for firms' extensive margins. Another research paper co-authored by Hans Lööf, explores the link between ESG and financial performance in the form of a value at risk analysis of European firms.

In 2019, technology and innovation in clean energy was the focal point of two research articles coauthored by Hans Lööf. While one article identified opportunities, capabilities and innovative outcomes in new ventures in cleantech, the other addressed technical change in clean energy by factoring evidence from the solar industry. Another working paper initiated in 2019 authored by Andreas Stefan and Hans Lööf, investigates the relationship between a firm's ESG score and its downside risk on the stock market. The paper was presented at the Hanoi University of Natural Resources and Environment, Shanghai University of Finance and Economics and the National Economic University of Hanoi.

The overarching aim of PAtLink project is to create and free of charge distribute a comprehensive matching file between patent and trademark information and organization information. The matching file will consist of the relationship between a unique patent/trademark identifier and a unique organization identifier. Patlink project is financed by Vinnova. The current files are the first series of information on patent and trademarks. The files will be updated annually.

The research program engaged in many scientific and educational activities over the course of five years. A seminal project was compilation of several databases including the creation of Swedish databases PATLINK 1 and PATLINK 2 with information on patents, investors, trademarks and economic characteristics with linking options to other commercial databases. Another extensive dataset featuring information on worldwide clean technology patents, regulations, taxes and financial sources for innovation activities with longitudinal data for more than 100 countries was compiled.

In 2017-18, a Master course on Green Economics was inducted as a part of the curriculum at KTH. Further, in 2018, two additional reports were published. While one explored the link between patents and firms' balance sheet, the other report focused on an econometric analysis of the impact of implementation of the new Sustainability Act for the EU Commission and the Swedish House of Finance.

Outreach activities in 2019 constituted presentation of the paper "The Impact of ESG on Stocks' Downside Risk and Risk Adjusted Return" for the Swedish government agencies Growth Analysis and AP7.

3.4 Governance:

The Governance work package aimed to encourage main-stream financial economists to start researching the transition towards a sustainable economy. The objective was to increase the general knowledge about the role of the financial sector in achieving a more sustainable economy by having these experts in finance broaden their research agendas to explicitly incorporate sustainability.

Research Highlights:

The long-term ambition of the Governance research stream was to produce top-level research combining financial economics and sustainability that is published in top-ranked, widely recognized finance and economics journals. Some strides were taken in 2016 towards this objective in the form of multiple conference presentations. Notably, affiliated researcher Anders Andersson presented for the Western Finance Association (WFA) in Utah, the European Finance Association (EFA) in Oslo and at the Behavioral Finance Working Group in London. Further, Sophie Nachemson-Ekwall presented papers on Swedish institutional investors as being value creating stakeholders and examined their larger stakes and long-termism in separate conferences at the Copenhagen Business School and European Academy of Management. Joakim Sandberg and Ulrika Stavlöt also participated in conferences at the University of Bayreuth and the National Conference in Economics respectively.

The Governance stream supported three research papers in 2017. Anders Andersson along with Forest Baker and David Robinson published a paper in the *Journal of Financial Economics* titled "Precautionary savings, retirement planning and misperceptions of financial literacy". In another article, Anders Andersson and David Robinson examined the link between self-awareness in terms of financial literacy and retirement savings decisions. The year was equally productive in terms of conference participation with Claire Celerer and Boris Vallee presenting on "Can Financial Innovation Solve Household Reluctance to Take Risk?" at NBER Behavioral Finance Meeting, EFA meetings, Brazilian Society Meeting and IFISD. Sophie Nachemson-Ekwall presented on corporate governance and the legitimacy of the nomination committee for the Nordic Corporate Governance Network and at ICGS in Rome.

In 2018 the research stream made further progress in terms of research output. Paolo Sodini, together with Laurent Calvet, Claire Celerier and Boris Vallee, worked on an impressive paper that investigated which households are likely to invest in complex financial products, and if such investments are

beneficial to individual portfolios. This paper was presented at top academic conferences including the NBER Behavioral Finance Meeting, the premier global conference on this type of topic. Gustav Martinsson's research paper together with James R. Brown and Christian Thomann examined how firms can shift corporate investment from dirty to clean production technologies in the wake of pollution taxes has been published as a working paper and presented, amongst other places, at the SHoF-MFS Conference on Sustainable Finance. Other journal article publications in *Technological* Forecasting and Social Change, Review of Financial Studies as well as International Company and Commercial Law Review were produced by the work stream. Similar to the previous years, Anders Andersson presented at the EFA, GLFEC Financial Literacy and the European Winter Conference. Further, in 2020, Laszlo Sajtos¹ successfully defended his PhD dissertation titled "Essays on Environmental Regulations" consisting of four chapters. The first two chapter focused on the review of the Swedish environmental regulation system from 1980s to 2019 and an assessment of the distribution and impact of Swedish carbon tax on firm-level carbon dioxide emissions and carbon intensity, together with Christian Thomann, Gustav Martinsson and Per Strömberg. The last two chapters incorporated investors' perspective on environmental regulations, investigating the effect of carbon tax on listed Swedish firms' market value and empirically evaluating the effect of the most recent structural reform of EU ETS on the regulated firms' market value and future expected profit.

Finally, Alexander Andersson made significant progress on his PhD dissertation in 2020. Alexander's doctorate studies were funded by MFS and planned to be completed by 2020. While he got delayed due to the Covid-19 pandemic, he is set to defend and graduate in 2021. His thesis consists of four chapters and focuses on a detailed analysis of the moral justification of CEO compensation starting from the philosophical questions around pay and justice, to a detailed empirical quantification of CEO pay and its components, and finally the development of normative principles for just compensation plans.

Outreach and other activities:

A number of outreach activities were undertaken throughout the five years of the project. These include various seminars, presentations, television interviews and newspaper articles. In 2016, Sophie Nachemson-Ekwall interviewed with Nasdaq and Tech of Sweden and presented with Peter Norman on Sustainable Ownership Governance at the MISUM seminar. In 2017, the JFE article co-authored by Anders Andersson found mention in the Wall Street Journal and Sophie Nachemson-Ekwall interviewed with *Sparbankernas Riksförbund, Riskkapitalföreningens, Sveriges Ingenjörer* and *Dagens Industri* among other outreach activities. The stream further participated in Women's Finance Day in order to increase knowledge and interest in finance among women. In 2017, Paolo Sodini conducted multiple seminars all over Europe and the US notably at Harvard University, Columbia University, HEC Paris and King's College. Further, in 2018, Paolo Sodini appeared in television interview with SVT to discuss the risks in the "Fire" movement behind saving enough money to be able to live on the returns.

3.5 Practical Tools:

Research Highlights:

During 2016, the ICMA Centre at Henley Business School worked in close collaboration with the financial sector on several of the Practical Tools research projects, including multi-year projects on engagement effectiveness, a benchmark study on ESG rating agencies and a research project on systemic risk. Furthermore, the research stream conducted a comprehensive empirical study on the performance implication of the exclusion decisions of two leading Nordic investors, Norway's Government Pension Fund-Global (GPFG) and Sweden's AP-funds. The authors investigated whether asset owners can meet ethical objectives through an exclusion-based strategy without compromising financial returns. The study resulted in a widely recognized paper, launched at a joint SweSIF seminar at the Stockholm School of Economics and published in the Journal of Business Ethics. Andreas Hoepner also presented at various conferences organized by the British Accounting and Finance Association, BAFA South Each Area Group and Financial Data Science Association Summer School.

The second year of the program was marked by high conference participation and a number of articles were published by Andreas Hoepner together with other researchers in prestigious journals. A journal

article titled 'Media Coverage of Climate Change: An International Comparison' was published in *Environment and Planning C: Politics and Space*. Another research article was published in the *Journal of Corporate Finance* and explores how emotional nowcasting can be converted into accurate action for climate change. A third publication in the *Journal of Business Finance & Accounting* evaluated the significance of information for corporate climate change disclosures and performance and further discussed if such information is appropriately priced. Andreas Hoepner presented at multiple conferences including the PRI Academic Conference in Berlin and those organized by the London School of Economics, Financial Data Association, Western Economic Association and the British Accounting and Finance Association.

In 2018, the research published three book chapters for volumes published by the CFA, Gower and Springer. Conference participated was marked by presentation by Andreas Hoepner at the American Finance Association in Philadelphia, Strategic Management Society in Paris and the British Accounting and Finance Association in London. In 2019, two journal articles titled 'Does an asset owner's institutional setting influence its decision to sign the Principles for Responsible Investment?' and 'State Pension Funds and Corporate Social Responsibility: Do Beneficiaries' Political Values influence Funds' Investment Decisions?' were also in the working for publication in the *Journal of Business Ethics*. Notably, the research paper titled 'ESG Shareholder Engagement and Downside Risk' was adjudged the 2019 PRI Best Quantitative Paper Award.





The final year of the program was characterized by prolific research activity and conference participation. Multiple research papers were published in journals including the *Journal of Economic Geography, Small Business Economics: An Entrepreneurship Journal, Research Policy* and *Environmental and Resource Economics.* For example, Fabiola Schneider who is working on her PhD within the Practical Tools workstream and is currently in the 3rd year of her studies has recently

published a paper on "In the Name of COVID-19: Is the ECB Fuelling the Climate Crisis?" joint with Prof. Andreas Hoepner and co-authors. The paper shows that the likelihood of an European energy company bond to be bought as part of the ECB's Covid-19 program increased with the greenhouse gas (GHG) intensity of the bond issuing firm. This indicates that some of the initiatives to fight the economic consequence of the Covid-19 pandemic might not be well-aligned with the goals to lower GHG emissions.

Andreas Hoepner also worked on two policy papers titled 'Taxonomy: Final report of the Technical Expert Group on Sustainable Finance' and 'Usability Guide: TEG Proposal for an EU Green Bond Standard' for the European Commission. Conference participation was marked by participation at the 20th, 21st and 22nd digital meetings of the EU's Technical Expert Group (TEG) on Sustainable Finance. Further, Andreas Hoepner made two plenary speeches at the SFI AI for Anti-Greenwashing Outreach Event and EU JRC Summer School on Sustainable Finance.

Outreach and other activities:

In 2016, the research stream engaged in several outreach and educational activities. Andreas Hoepner participated in a number of panel discussions at the MSCI Annual Conference on Global Investing & Risk Management, Annual CSR Investing Summit, Stockholm School of Economics and *Deutscher Stiftungstag* among others. He also served as the Chair to Keynote at the Global ESG Investment Forum held in London besides being the keynote speaker for Bloomberg in Tokyo. In 2017, key outreach activities included an interview with the New York Times on "GHG targets & reporting", a roundtable discussion with Damian Borth at Allianz Investment Management in Munich and a webinar with Franklin Templeton and K2. Seminar participation was market by participation at Nord LB Asset Management in Hannover, Deutscher Bund Umwelt in Osnabreuck, SEB in Solna and the CSEAR Seminar at the Hong Kong Polytechnique University.

In 2018, the SDG Attention Indices were published for four SDGs and Andreas Hoepner was appointed to the EU's Technical Expert Group on Sustainable Finance, advising on European policy. Additionally, the research stream participated in many seminars held by MFS and AP1 in Stockholm, Risk Management Department, NBIM in Oslo and Singapore, Bloomberg in New York, Akuna Capital in Chicago, Fidelity International, Blackrock and AQR in London. Andreas Hoepner also participated as a keynote speaker at the ESG Day at DWS in Frankfurt and made a plenary speech at the UBS Quant Conference. Outreach activities in 2019 were equally international and across a range of platforms as in previous years. Seminar attendance was registered at the United Nations University in Tokyo, at the Hong Kong Polytechnique University, University College Dublin and Center for Business and Society (CeBaS) in Dublin and the World Bank Pension Fund in Washington D.C.

In the final year of the program, multiple interviews were held with the Irish Times, the Wall Street Journal, FTSE, IPE and S&P Global. Webinar participation was registered at Calvert, StepStone, IPE, CFDS, Bank of Ireland, Deloitte, Research Affiliates and Morgan Stanley. Educational outreach was in the form of executive educational programs at Brunel Pension Plan, DVFA and Institute of Bankers. Participation in a number of digital roundtable seminars was recorded during the year.

4 MFS' CONTRIBUTION: SYSTEMATIC APPROACH, NEW DATA AND INTERNATIONAL POLICIES

Independent of its workstreams, MFS has actively organized a number of conferences and outreach activities at the program level to contribute to its ultimate objective of enabling better financial systems to support a sustainable society. Notably, the MFS-UNEP Inquiry Seminar launched the collaborative study, "Finance and Innovative Investment in Environmental Technology: The Case of Sweden" conducted by Hans Lööf, Gustav Martinsson and Ali Mohammadi as well as a discourse centered on Sweden's role in sustaining green finance. Seminars and conferences organized by MFS in collaboration with financial institutions and investment firms such as SweSIF, AP7, Skandia, TBLI, Feminvest, SEB, Swedish Institute Sustainability Forum and Sida focused on responsible investing and financial decision-making, green finance, aligning portfolios with the 2 degree scenario and the challenges in scaling up investments in green finance. Further, MFS also explored the possibility of a free access to the Dow Jones data for academic research. In 2020, MFS conducted a seminar with Riksbank Vice President Anna Breman and the Stockholm Sustainable Finance Center where MFS affiliates collaborated with the Swedish Governmentt and SweSIF. There were a range of informal briefings and working meeting with high-level policy-makers like the former Swedish Minister of the Environment, Isabella Lövin and government agencies such as Tillväxtverket, Vinnova and Naturvårdverket.

Andreas Hoepner of the Practical Tools research stream has worked with the European Technical Expert Group since its inception in 2018 to set clear standards for ESG, climate disclosures and benchmark assets, conducive for the EU's climate strategy. Subsequently, based on the empirical findings and the policy recommendations from the UN IPCC, two benchmarks for equity and corporate bond markets: The EU Paris-Aligned Benchmark (EU PAB) and the EU Climate Transition Benchmark (EU CTB) were developed. The model of the EU PAB is unprecedented, as no other benchmark so far uses absolute emission targets. The TEG has been the first to build an absolute target of net-zero carbon emissions by following the Intergovernmental Panel on Climate Change (IPCC) goals. Notably, some investors and benchmark providers have already committed to the new benchmarks, according to the IPE magazine² such as the MSCI and S&P Dow Jones Indices.

In 2020, MFS planned a three-part webinar series to publicly convey the research highlights of all the MFS workstreams together, linked to the objective of transdisciplinarity and a more systematic view of sustainable finance. Denise Young, host of the podcast series on New Climate Capitalism was roped in to moderate insightful discussions and she will continue the engagement with MFS affiliated researchers in the future. The first MFS research seminar addressed factors imperative to decarbonization and sustainable investments – challenges in the availability of useful data, need for technical discourse and a narrative based approach, and the influence asset owners can exert in nudging companies to report carbon emissions accurately. Andreas Hoepner highlighted five building blocks for climate transition investing: reducing GHG emissions as compared to market benchmarks, year-on-year reduction in GHG emissions by seven percent, reaching net zero emissions by 2050 and integrating scope 3 emissions. The discussion highlighted challenges in emission reporting such as sampling issues, lack of adequate breakdown by division, extrapolation and reporting boundaries

which make precise reporting considering difficult and together with a lack of incentive, result in underreporting and unavailability of accurate data. Addressing the same issue, Gustav Martinsson of the Governance work stream underscored the role MFS has played in bridging the gap between environmentalists and economists with the establishment of a cross-disciplinary platform that has facilitated matching data from two different streams towards technical research.

Further, in their research paper that fills an important gap in the literature, Gustav Martinsson and other researchers found that carbon pricing is inversely related with firm-level emissions and reiterated the effectiveness of low marginal tax rates in comparison to the relatively higher average effective taxes based on Swedish industry data. Apart from the effectiveness of policies, their role as a source of data that generates insights for future decision-making was also highlighted.

In terms of positive changes in the past five years, Andreas Hoepner lauded the ambitions set by the European Commission on climate change and the complementary actions by the European Parliament in passing supportive legislations. The European Technical Group on Sustainable Finance also drew praise from independent consulting firms for its efficiency in delivering on its objectives. Gustav Martinsson also pointed out the greater awareness and interest amongst university students who not only demand climate topics to be incorporated into university courses but also carry forward research by authoring theses on such topics. The discussion underlined the importance of both a narrative based approach to enhance general understanding as well as a more technical approach for decision-makers to base their policies on.

The second MFS research seminar discussed valuable research on systems thinking, tipping points and the future of sustainable finance conducted by the Green Macro and Policy work streams. Victor Galaz discussed the notion of sleeping giants and tipping points in the earth's climate system such as the Amazon forests which are important for climate stability, biodiversity and ecosystem services. In one study, the Policy stream researchers identified sizable financial institutions that have investments in companies that adversely impact several or all such tipping points and are thus contributing towards rapid climate change. A second study focused on financial flows in the form of loans and development finance to companies operating within these 'tipping points' and found that a major share of foreign capital comes in from tax havens such as Caymen Islands and the Bahamas with little transparency. The results of both the studies generated widespread media attention in Sweden and abroad. Notably, 230 big investors called on firms and the Brazilian government to deal with deforestation and forest fires in the Amazon predominantly citing the first study. Further, through multiple roundtables and seminars, the Policy stream was successful in initiating a dialogue on tipping point dynamics by engaging with a host of financial stakeholders.

Eric Kemp Benedict then presented the research undertaken by the Green Macro research stream which sees the economy as a *going concern* and discussed the mechanics and implications of replacing stranded assets with a new sector by examining the cascading forward and backward linkages. Another study examined how sectors sensitive and insensitive to the amount of green capital in the economy transition to non-fossil fuels under four different policies – such as inaction, environmental tax, setting a deadline and preferential bank rates for green investment. The research on cascading effects won the Best Paper prize at two academic conferences, viz. the European Society of Ecological Economics (ESEE) Conference and the Global Research Alliance for Sustainable Finance (GRASFI) conference. The discussion further highlighted the importance of viewing climate change as

a systemic risk for the financial sector rather than regarding it as a separate component and the need to focus on the cascading or network effects that accelerate climate change.

The third and final research seminar probed why sustainability values matter for firms, investments and market development and further discussed how finance can contribute to a transition to a low carbon economy. Anders Anderson of the Governance workstream explored the link between financial literacy, green value orientation and participation in the financial markets in Sweden which has important takeaways for policymakers. The research paper had three principle findings: first, a mistaken belief about environmental literacy is associated with mistaken beliefs about investments. Second, more than 65 percent of those surveyed agreed to a cleaner planet being more important than higher financial welfare. This green value orientation was also found to carry over to the beliefs about performance fees for green investments. And finally, people with a greener orientation were more likely to be without high financial literacy and hence with lower stock market participation. The research thus points towards an opportunity for an intermediary that can help consumers have their true preferences reflected in the financial markets. This together with the fact that increasing the

Having considered a consumer's perspective to green investments, Hans Lööf of the Market Drivers work stream next discussed three papers addressing firms' performance in relation to green investments. The first research paper co-authored with Andreas Stefan investigated the impact of ESG ratings on firms' downside risks considering firms from different industries. The finding provided evidence that broad shareholder values that factor in ESG concerns might be beneficial for firms and market value due to the reduced downside risk – in the form of reduced interest on bank loans, an

improved possibility for bank loans and increased attractiveness for risk capital which improves firms' capacity for long-term investments related to the transition to sustainable growth.

Another research paper discussed whether new ventures in cleantech differ from other ventures by employing propensity score matching that pairs clean tech ventures with similar non-cleantech firms. The study stated that cleantech startups have a higher likelihood of fostering innovation and leadership as their initial business strategy. Further, cleantech startups were found to have higher innovation capabilities and were more likely to create products and services that are new to the regional market. They were overall, less dependent on various forms of public support as compared to other ventures while competing on similar terms. The third paper assessed policies fostering technological change and innovation that spurred renewable energy growth in the context of solar PV. The research indicated that increased energy prices positively impact investments in renewable energy and the number of patents. Moreover, public R&D support resulted in increased patenting and direct investments in solar PV in public buildings and other areas. Thus, government policies in terms of targeted directed technical change and increased prices have an important effect on the growth of solar PV in Europe.

The subsequent discussion highlighted the need for greater financial literacy and improved financial engagements especially for those with a strong green orientation and the need for a single reliable ESG measure that can reduce uncertainty and bring consistency in measurement. The discussion further underlined that government policies should focus more on the innovation potential and risk reduction of companies instead of high returns in the short-run.

To conclude, MFS has successfully provided an impetus to research in sustainable finance within Sweden. It has brought together researchers from different institutions as well as different academic fields and has provided them with a platform to discuss, engage and collaborate. MFS has had a profound impact on the participating institutions and people – not just by supporting their research but also by preparing the stage for follow-up initiatives and a continuous engage in sustainable finance.

As discussed before several times in this report and in the context of financial markets, having the right planning horizons is important. This holds for firms and financial markets but also for research in sustainable finance. A continuous, systematic, comprehensive and academically sound effort is required and MFS played an important role in getting such an initiative started in Sweden.
